I am writing this letter to request an extension to my maternity leave for the purpose of child rearing. I am requesting a leave of absence, using unpaid sick days, beginning on Monday, December 3, 2012 and continuing throughout the remainder of the 2012-2013 school-year.

Currently, my son Tyler commutes with me each morning from Old Bridge to his babysitter in Union. He is having a difficult time handling the long commute through traffic as he is vomiting in the car daily due to motion sickness. Also, he refuses to take milk from the babysitter. Since his weight is on the low side for his age, it is necessary that he consumes an appropriate amount of milk each day. My husband and I have explored other childcare options, finding that they would not be suitable to our family's needs. The childcare centers near my home do not open early enough to allow time to drop my son off and still arrive at work on time. We also looked into in-home childcare, finding that we could not afford the rates being asked.

It is necessary for my leave to take place as soon as possible due to the reasons indicated above. This time frame would allow me to finish out the marking period with my students and post grades. A replacement teacher could begin fresh with a new marking period, making the transition a little easier for the students, parents, and teacher.


