Through this mentoring program, students would receive various life skills training that goes beyond what they may be exposed to in the classroom, such as developing self-control & discipline, focusing, accountability, the value of following instructions, etc. All of this would be conducted in a healthy environment by our own positive role-models. Our program would also assist in supporting both the parents and children of those in single-parent homes.

The outcome of CCC's mentoring and life skills training program would result in better academic performance, positive self-image, and over all contributing to this community. It provides a healthy alternative to "falling in between the cracks".

Lastly, we would request that the district also wave any and all rental fees and any other fees associated; as we do not look to monetarily capitalize from this program, only to benefit the community in which it is run. There is no charge to any participant. In addition, our entire team of mentors and assistants is fully comprised of volunteers who only have the interest of the youth and the betterment of this community as their agenda.
