This letter is sent as our proposed budget between Union Township Public Schools and ARAMARK Education for food service in the 2015-2016 school year.

We are proposing a guaranteed surplus of \$164,387. In order to meet this budget, we made the following assumptions:

 Price increase of \$0.10 for paid breakfasts and \$0.20 for lunches at all grade levels. The increases are per the guidance issued by the Department of Education.

- The Department of Education guidance is due to the changes under the section 205 of the "Healthy, Hunger-Free Kids Act of 2010". This regulation requires the program to provide the same level of support for lunches served to students who are not eligible for free or reduced price meals as they do for meals served to students eligible for free lunches. SFA in the continental US currently charging less than \$2.70 for a paid lunch are required to gradually increase prices or provide additional non-Federal support for its lunches. As per USDA Paid Lunch Equity memo; SP 03-2015, October 8, 2014.
- No change in state reimbursements.
- Federal reimbursement has an additional \$0.06 for Performance based lunch reimbursement.

ARAMARK's total fees are described below.

- Administrative Fee \$ 0.1375 cents per meal; no increase in fees due to CPI being 0%
- Management Fee \$0.0527 cents per meal; no increase in fees due to CPI being 0%
- Equivalent Meal Factor \$ 1.00
- Service Days 176
- Current Enrollment 7,587
- Unlimited guaranteed return \$164,387
